Mayor Pro tem Gary Long opened the meeting at 7:00 pm.

Roll Call Completed:

Meeting Minutes:

 Virginia Kenny made a motion to accept the Nov 18th, 2024 meeting minutes. John Dankoski seconded the motion. All were in favor.

Treasurer's Report:

• Virginia Kenny made a motion to accept the treasurer's report; it was seconded by Elvira Rowe. All were in favor.

Monthly Bills:

• Sheryl gave updates on the bills. Virginia Kenny made a motion to pay the bills; it was seconded by Elvira Rowe. All were in favor.
